We hope you will review the attached guidelines, and, if you meet the eligibility requirements, send your manuscript to Poets & Writers.

CONTEST GUIDELINES

Eligible Writers

California poets and fiction writers who:

1. Have never published a book, or;
2. Have published no more than one full-length book (excluding self-published books and chapbooks) in the genre in which they are applying, and;
3. Have resided in California for at least two years immediately prior to the date they submit their manuscripts.

Writers may apply in the poetry and/or fiction categories (only one manuscript per category).

Writers may not be previous winners of contests sponsored by Poets & Writers, Inc.

Finalists will be asked to submit verification of publications and residency.

Employees of Poets & Writers, Inc. are not eligible.

Awards

One California poet and one California fiction writer will be selected. The names of the winning writers will be announced by e-mail and on our Web site (www.pw.org) in December 2012. Each winner will receive:

1. A \$500 honorarium;
2. A trip to New York City in spring 2013 to meet with editors, agents, publishers, and writers. All related travel/lodging expenses and a per diem stipend are covered by Poets & Writers. Winners will also give a public reading of their work.

Manuscript Requirements

Poetry manuscripts should not exceed ten pages (and should contain a minimum of seven pages), single- or double-spaced, with no more than one poem per page.

Fiction manuscripts should not exceed twenty pages and must be double-spaced. Fiction manuscripts may include stories and/or excerpts from novels. You may specify whether a fiction piece is a novel excerpt, but plot summaries will not be accepted.

Manuscripts must be typed on 8.5" x 11" white paper in a standard font. Submit four collated copies of your

manuscript (good quality photocopies are fine). Each of the four copies should be bound with a single clip. Please refrain from using staples, folders, or special bindings.

Previously published work may be submitted; however, no photocopies from books or magazines are acceptable. This work should also not be identified as previously published.

All work must be original and written in English; translations are not eligible. There are no restrictions on style or subject matter.

Your name or address should **not** appear anywhere on the manuscript.

There is no entry fee required.

Submission Procedures

Submit **four collated** copies of your manuscript.

Enclose a signed contest entry form with your manuscript. If you are submitting in both the poetry and fiction categories, complete a separate entry form for each.

All manuscripts must be postmarked no later than
August 31, 2012.

If you want Poets & Writers to acknowledge receipt of your manuscript, please enclose a stamped, self-addressed postcard with "California Writers Exchange" written on it.

Manuscripts will not be returned, and Poets & Writers cannot assume responsibility for the loss of manuscripts.
